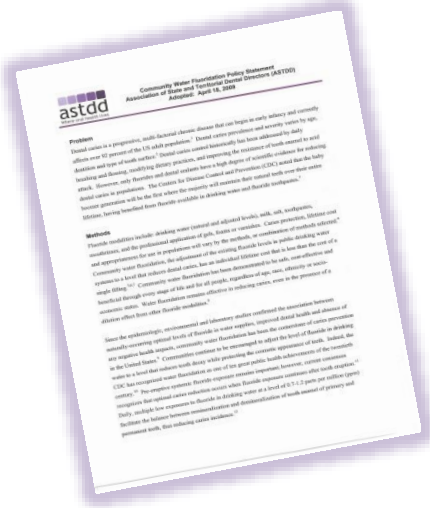


ASTDD develops and disseminates evidence-based dental public health resource documents in support of states' priority issues. These include white papers, issue briefs and other resource statements.
